## Secondary Spirit Marks

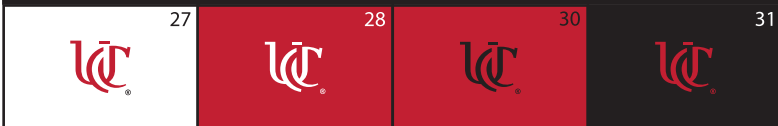


## Primary Institutional Marks

## ADDITIONAL PERTINENT INFORMATION

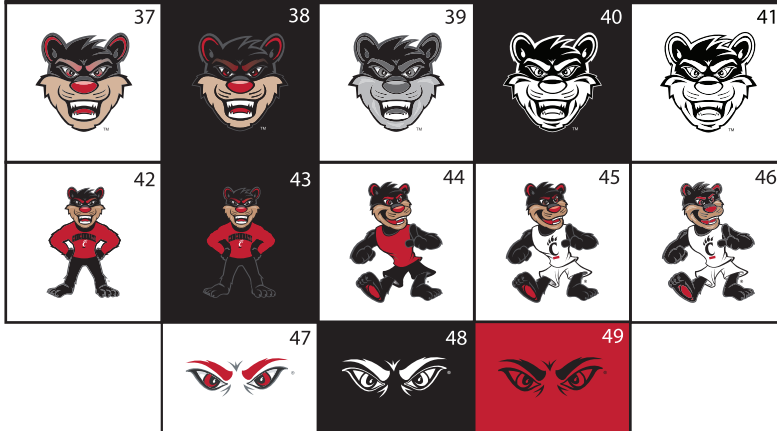
- University Alternate Seal permitted on products for resale (prior approval required)

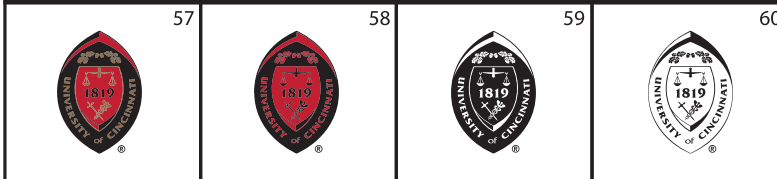

## Fashion Color Uses

When using fashion colors, University mark must be shown in all-white or all-black, whichever shows greater contrast.



## Established Dates

The Year 1819 should be used as the Established Date for all designs related to the University of Cincinnati unless they are referencing a specific sport/department, in which case they should use the appropriate date for that unit (i.e. Baseball - 1879, Football - 1885, Department of Athletics - 1890, Men's Basketball - 1901, Women's Basketball - 1971, Men's Soccer - 1973, Women's Soccer - 1980)
